1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

Provided 1. Vision exams to 233, glasses to over 120 and dental exams and treatment to 140 kids in the underserved, rural area of Ensenada, Mexico. The value of these services was \$125,662. This was over 2 separate clinics in Oct 2024 and the second was 3-15-25.

2. How many Rotarians participated in the project? 55 Rotarians.. 13 Rotary Exchange Students and 5 Rotaractors.

3. What did they do? Please give at least two examples.

They helped the Doctors load and unload the Dental Van, restocked the van, set up the dental rooms, set up the Xray station, managed the flow of patients as the children arrived and while they waited. We prepared the classrooms for the dental equipment, acted as assistants, helped clean up, etc. They helped with the setting up and taking down the room used for the Vision clinic. Conducted examinations for the vision patients, performed eye chart examines, fitted glasses, etc. There were work projects as well. They cleaned up the premises, painted walls, gates and benches

4. How many non-Rotarians benefited from this project? 495 mostly elementary school kids plus some adults.

5. What are the expected long-term community impacts of the project?

Kids that can see do better in school and as a result will likely have more opportunities to excel in the world. Kids who are healthy do better in school and have parents who do not lose work time taking care of a sick child. Secondly, we create long-term relationships. This creates a larger community of partners. It builds goodwill and is the soft power toward peace. We build bridges and expand our community in the world.

6. If a cooperating organization was involved, what role was its role?

Dental Care for Children provides the dentist, dental students and performs the dental work. Manteca Optometric provides vision examinations and dispenses glasses to those who need them.


