1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The project was completed at Boys and Girls Club facility in Fountain Valley, CA. We purchased food that we assembled and sent to Third world countries.

2. How many Rotarians participated in the project? Over 70 individuals participated, of which approximately 30 were Rotarians (this includes Fountain Valley and Surf City (Huntington Beach) rotary clubs.

3. What did they do? Please give at least two examples.
 1 Worked in an assembly line to assemble and seal the food packages.
 2. Packaged all the food packets up in boxes for shipping.

4. How many non-Rotarians benefited from this project?
 We processed over 10,000 (10,142) food packets each which serves an entire family – so our best guess is in excess of 40,000 people.

5. What are the expected long-term community impacts of the project?
 We helped sustain starving people.

6. If a cooperating organization was involved, what was its role?
 We partnered with Surf City Rotary and Rise Against Hunger. Rise Against Hunger provided food and packing materials. The Rotary Clubs provided the manpower to prepare the packets of food for shipment. And Fountain Valley Kiwanis Club provided complimentary lunch for the volunteers and Chef Marla McGee provided a complimentary dessert.
