Project Overview

Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

This is a long-term sustainable project aimed at more than doubling the crop yield of Filipino farmers through scientific and precision farming methods. The project includes the formation of an RCC to be consisted by the farmer beneficiaries, who will be trained on becoming a self-managed business unit, with proper values as a person and as member of a family and community, with technical knowledge on precise soil analysis, preparation and fertilization, and crop management. With the application of the technical knowlege, from the current harvest of 2 tons/hectare, it is expected to more than double the harvest to 5 tons/hectare on the 1st planting cycle and will gradually increase to 9 tons/hectare up to the 4th cycle. The direct beneficiaries are 50 farming families of Barangay Casalat, San Ildefonso, Bulacan, Philippines who are members of Casalat Agventures Farming Association (CAFA) that will then be formed as a Rotary Community Corps (RCC).

The host club will lead the project management including sourcing suppliers for soil nutrient inputs, plant biostimulants, and crop seeds. It will monitor the conduct of farmers' training on crop management, soil analysis, and soil nutrient inputs. It will also coordinate with the monitoring of project progress and evaluation. The host club will also coordinate with project partners including the conduct of monitoring and evaluation.

The international sponsor will supplement the funding of the project and help in the monitoring and evaluation of the same.

Describe how the partnership between the host and international sponsors was formed. What agreement have the sponsors made toward ensuring that the project will be implemented successfully? How will they manage any challenges that arise throughout the project?

A member of the host club (PP Erwin Veneracion) is a relative of the Charter President (CP Romeo Villanueva) of the international sponsor. The previous club of PP Veneracion (RC San Rafael) is a sister club of RC Sweetwater San Diego, and they had joint club project in the Philippines, specifically the donation of two (2) units of oxygen concentrators for government hospitals in Bulacan, Philippines. Likewise, both clubs have chances of visiting the club meetings both in San Diego, California and Bulacan, Philippines. When the RC San Rafael was delisted from RI, PP Erwin Veneracion joined RECBTN and suggested the sisterhood with RCSWSD and inviting them to be partners of the project.

Apart from providing the necessary financial counterpart, the sponsors (being Filipino-Americans) regularly visit the Philippines. They will be monitoring the implementation of the project and will be visiting the project sites.

A sisterhood agreement between the host and international sponsor will be inked.

Project planning

Describe the community needs that your project will address.

During the community needs assessment, farmers have identified increasing productivity and family income as their top priority needs, which if addressed, could create a big difference in their lives. According to them, because of their financial difficulties, they are reliant on government subsidies such as seeds and fertilizers which may not be appropriate and sufficient hence their harvest is much below than the national average, a hectare of land can only harvest 40 cavans. Considering the operational and manpower costs of farming and to include their daily living cost, farmers are often victimized by loan sharks charging exorbitant interests. This cycle of poverty can be solved by increasing remarkably the yield of farmers. The project therefore will focus on remarkably increasing the production of rice farmers in the target community.

How did your project team identify these needs?

The Rotary E-Club of Bulacan True North (RECBTN) with the help of the Extension Workers from Bulacan Agricultural State College (BASC) gathered data on the current status of the farming community of Brgy. Casalat, San Ildefonso, Bulacan as the target beneficiary community of the proposed project. A total of 35 rural farmers who are all active members of Casalat Agventurers Farmers Association (CAFA) in Casalat, San Ildefonso Bulacan served as the survey respondents. Meanwhile, three key informants composed of the Chairman of their Association - Mr. Elino R. Zausa, the Barangay Councilor in-charge of agriculture sector in their barangay, and one potential farmer beneficiary were the participants of the FGD.

The team employed a combination of survey method and focus group discussion techniques in gathering data from the respondents. The survey questionnaire collected personal information, farming practices, farm production, marketing practices, financial information, and problems being encountered by the farmers. The guide questions used by the team during the FGD asked information on the community background and situation, community needs, and priorities.

How were members of the benefiting community involved in finding solutions?

The surveys and focus group discussions conducted for community needs assessment delved into getting suggestions on the solutions to the problems of low crop yield and other phenomenal problems of the community. Among all the farm issues identified, the proposed solution is to address first the inappropriate and insufficient fertilization being practiced by the farmers which could be the major cause of crop failure. A few of the farmers mentioned that they have tried soil testing before but they cannot afford the additional cost of bio-fertilizers, hence they have to fall back to their old practices.

How were community members involved in planning the project?

The project concept was presented to the members of the benefiting community, their comments and suggestions were properly considered such that an agreement was reached on how to go about the project.

There is no local initiative currently addressing the priority needs of the community on increasing rice output of farms through the application of technologies already mentioned above.

Please describe the training, community outreach, or educational programs this project will include.

The trainings that will be provided to the farmer beneficiaries include values formation, organizational training, financial management, soil testing and analysis, determination of required soil nutrients, proper soil preparation, precise application of inorganic and bio-fertilizers, proper crop management including irrigation, use of foliar sprays, and proper drying and storage of harvest.

How were these needs identified?

The trainings are consequent to what are needed to be done in implementing the project and for the attainment of its objectives.

What incentives (for example, monetary compensation, awards, certification, or publicity), will you use, if any, to encourage community members to participate in the project?

From the community needs assessment, it was gleaned from the data that the farmers exhibit high levels of willingness to participate in the project. To build on their willingness to participate, they will be enticed further with trainings to be conducted. Recognizing farmers who logged the highest yield and highest yield difference will also be part of the project evaluation and post-assessment. With the expected end result of multiplying their current production and income, without additional cost on their part should be more than enough incentive for them to participate in the project.

In terms of publicity, local news outlets and social media pages will be invited to cover the project launch, monitoring phase, and post-project assessment. The RCC and its members will be properly recognized with their participation in a game-changer rice farm production project.

RECBTN as sponsor of CAFA-RCC will continue to oversee the continuation of the project to ensure that the grant fund will continue to be revolve and be used to benefit more farmers and for other investments such

as for drying facility that will provide more benefits and income to the farmers. CAFA-RCC will be capacitated through trainings and guidance so that it will have the ability to continue the project with lesser intervention from RECBTN and suppliers/partners.

Vendors were asked to provide bids for the supplies (i.e. soil nutrient inputs like soil conditioners, fertilizers, foliar sprays, knapsack sprayers) and for training needs (e.g. crop management recommendation and farmer's training on crop management) and technical assistance. Vendors were vetted and bids verified.

The equipment to be purchased in this project is a very simple and standard knapsack sprayer that with very few moving parts hence very easy to operate and maintain. Most farmers are already familiar with the said equipment hence will need very little orientation. Each farmer beneficiary will receive one unit which they will own. operate and maintain. The RCC as a group can assist any farmer-member in case he is having problems with his sprayer that he cannot solve on his own.

Describe how community members will maintain the equipment after grant-funded activities conclude. Will replacement parts be available?

As mentioned above, the knapsack sprayer is a very common and standard farm equipment that can be easily and cheaply maintained. Spare parts are available from the supplier and other farm equipment stores.

The knapsack sprayer will be owned each recipient farmer. The grant fund will be maintained as revolving fund of CAFA-RCC which they can reuse on succeeding farm cycles but with close monitoring by RECBTN. Future decision to invest the fund to other projects such for a drying facility that will result to more benefits and income for the farmers can be done only with the concurrence of RECBTN.

Yes, each farmer beneficiary who are members of the CAFA-RCC will be required to pay 10% of their gross profit (as shown in the attached Financial Projections) as membership fee to the RCC. That is if they will continue to fully avail of the revolving/grant fund for the additional expenses that will be incurred because of the project implementation. However, the farmer may later opt to reduce its availment of the revolving fund which will proportionately decrease his membership fee.

TRF reserves the right to cancel the grant and/or this Agreement without notice upon the failure of either or both of the Sponsors to abide by the terms set forth in this Agreement and the Terms and Conditions. Upon cancellation, TRF shall be entitled to a refund from the Sponsors of any global grant funds, including any interest earned, that have not been expended.
- 7. The laws of the State of Illinois, USA, without reference to its conflicts of laws principles, shall govern all matters arising out of or relating to this Agreement, including, without limitation, its interpretation, construction, performance, and enforcement.
- 8. Any legal action brought by either party against the other party arising out of or relating to this Agreement must be brought in either, the Circuit Court of Cook County, State of Illinois, USA or the Federal District Court for the Northern District of Illinois, USA. Each party consents to the exclusive jurisdiction of these courts, and their respective appellate courts for the purpose of such actions. Nothing herein prohibits a party that obtains a judgment in either of the designated courts from enforcing the judgment in any other court. Notwithstanding the foregoing, TRF may also bring legal action against Sponsors and/or individuals traveling on grant funds in any court with jurisdiction over them.
- 9. This Agreement binds and benefits the parties and their respective administrators, legal representatives, and permitted successors and assigns.
- 10. If any provision of this Agreement is determined to be illegal, invalid or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect.
- 11. Sponsors may not assign any of their rights under this Agreement except with the prior written consent of TRF. Sponsors may not delegate any performance under this Agreement without the prior written consent of TRF. Any purported assignment of a Sponsor's rights or delegation of performance without TRF's prior written consent is void.
- 12. TRF may assign some or all of its rights under this Agreement to an associate foundation of TRF. TRF may delegate any performance under this Agreement to an associate foundation. Any other purported assignment of TRF's rights or delegation of performance without the Sponsors' prior written consent is void.
- 13. Sponsors will comply with all economic and trade sanctions, including those implemented by the Office of Foreign Assets Control (OFAC) of the United States Department of Treasury, and will ensure that they do not support or promote violence, terrorist activity or related training, or money laundering.
- 14. This Agreement constitutes the final agreement between the parties. No amendment or waiver of any provision of this Agreement shall be effective unless it is in the form of a writing signed by the parties.
- 15. Rotary may use information contained in this application and subsequent reports for promotional purposes, such as in Rotary magazine, in Rotary Leader, on rotary.org and on social media. For any and all photographs submitted with any application or follow-up report, the Sponsor hereby grants to Rotary an unlimited, perpetual, worldwide right and license to use, modify, adapt, publish, and distribute the photograph(s) in any media now known or hereafter devised, including but not limited to, in Rotary publications, advertisements, and Websites and on social media channels. The Sponsor represents and warrants that (a) each adult appearing in the photograph(s) has given her/his/their unrestricted written consent to the Sponsor to photograph them and to use and license their likeness, including licensing the photograph(s) to third parties, (b) the parent or guardian of each child under age 18 or each person who lacks legal capacity appearing in the photograph(s) has given unrestricted written consent to the Sponsor to photograph the child or individual and to use and license their likenesses, including licensing the photograph(s) to third parties, and (c) it is the copyright owner of the photograph(s) or that the copyright owner of the photograph(s) has given the Sponsor the right to license or sublicense the photograph(s) to Rotary.
- 16. Privacy is important to Rotary and any personal data that the Sponsor shares with Rotary will only be used for official Rotary business. The Sponsor should minimize the personal data of Grant beneficiaries that it shares with TRF to only personal data that TRF specifically requests. Personal data that is shared with TRF will be used to enable the Sponsor's participation in this Grant process, to facilitate the Sponsor's Grant

experience and for reporting purposes. Personal data provided to TRF may be transferred to Rotary service providers (for example, affiliated entities) to assist Rotary in planning Grant-related activities. - 19. Except as disclosed here, neither we nor any person with whom we have or had a personal or business relationship will benefit or intends to benefit from Rotary Foundation grant funds or have any interest that may represent a potential conflicting interest.
