### Project Description:

83 sets of bedding (comforter, sheets, pillows, blankets) were purchased to distribute to Foster care families in Weld County at the annual Christmas party for these families. Shipments were unpacked and rewrapped with bows by Rotary members and brought to Island Grove Exhibition Hall where Weld County Legal Services hosted this Christmas party for Foster care families. The event took place over two evenings and Rotary members volunteered both evenings and helped set up, distribute food and drinks, welcome families, help choose bedding for families, helped families take gifts to cars.

Unpacked shipments of bedding, wrapped, and delivered to the Foster Care Christmas party location.

Distributed bedding at the party and helped with many other chores to help the hosts with the party (ie: set up the event, helped serve food and drinks, welcomed families)

Families in Weld County that provide foster care, also grandparents and family members who are raising children for other family members. Families were provided with a necessary item that will last at least 1-2 years and provide a child with warm bedding. We have been asked to participate annually if the Club would like to continue to do so.

7. If a cooperating organization was involved, what was their role? The Department of Legal Services of Weld County hosted the event and we worked with them to help provide the bedding and also to help at the Christmas party.

The event took place over two evenings and the time commitment was only about 2-3 hours per evening.
