The annual event, established and run by CSU employee and community volunteers, took place over four days in August. During the four days, hundreds of volunteers filled backpacks with grade-appropriate school supplies from lists provided by PSD teachers

and distributed them to schools. Now in its 33rd year, School Is Cool has helped more than 58.00

Now in its 33rd year, School Is Cool has helped more than 58,000 children start the school year off right.

The cost of each filled backpack was \$30 and a robust fundraising campaign, including an incredibly generous \$2,400 matching grant from Fort Collins Rotary and Rotary District 5340, allowed School is Cool to meet its goal and provide 2,500 backpacks to children in our community.

Packing the backpacks with school supplies was done in a room at Colorado State University and backpacks delivered to each school in the district. School employees distribute the backpacks to students in need.

Volunteers included teachers, school district volunteers, former School is Cool backpack recipients, members of Front Range Community College and community volunteers, including Fort Collins Rotary members.

Underserved K-12 students received backpacks to allow them to start the school year off with the specific school supplies required by their schools. The families of these children would not have been able to afford the supplies and a new backpack for their children. The long-term community impact is that children and their families feel cared for by our community and receive the tools they need to be successful in school. This project – now in its 33rd year – has served children who now give back to the community by volunteering to help others.
