(1) Concisely describe the project's progress during the period covered by this report.

Rotary Foundation released the payment on 7th Feb 2012. Host discussed withe manufacturer & placed the order for 27 set of sanitary napkin vending machine. Instructions were given to the schools to be ready to receive the machines and to install the machines. Supplier was advised to produce the machines, deliver to the respective schools with proper acknowledgement, to install the machines, to delivery 500 napkins for buffer stock, to educate the school management to operate, maintain & refill the machines; to educate the students about how to use the machines. The supplier demanded 6 weeks time prepare the machines and to deliver.

Since the DG & first lady of Dist. 5340, who are the International Sponsor planned to visit the project sites in 3rd week of March, the supplier was advised to deliver 5 sets of machines for the inauguration.

On 19th March 2012, International Sponsor visited the project sites, checked the functionality of the machines & inaugurated the project in two schools namely Government Girls Higher Secondary School, Karur & Government Higher Secondary School, Velliyanai. The other school managements were also invited to attend the project inauguration. The International sponsor addressed the school managements & students, about the importance of menstrual hygiene, safe disposal of used napkins, why Dist. 5340 and Rotary Foundation supported this project, & etc.

Since the schools are closed for summer holidays from 1st April 2012 & will reopen only after 1st week of June 2012, the installation & orientation programs can be conducted after the school reopening, which is after 1st week of June. Meantime, the supplier completed the production of the machines and start delivering the machines to the respective schools.

(2) Describe how the project has advanced the goals of the selected area(s) of focus.

The project is certainly advances the goal; to improve the menstrual hygiene by providing awareness & sanitary napkin vending machines; safe and hygiene method of disposal of used sanitary napkins. Since this project is still in progress and in beginning stage, host sponsor can give more details in final report.

To improve the menstrual hygiene among school / college girls by providing Sanitary Napkin Vending machines in school/college premises at affordable cost.

To dispose the used napkins in a safe/hygiene method by providing Incinerators in the girls toilets of school/colleges.

To create awareness among girl children about the importance of menstrual hygiene, the usage of sanitary napkins, & importance of safe/hygiene method of used napkin disposal

Order placed for Sanitary Napkin Vending Machines & Incinerators. Already installed in two schools and got very good feedback from the teachers and girl students.

The International sponsor witnessed the installations, attended the inauguration and addressed the teachers and students about the objectives. Once the schools are reopen after the summer holidays, the machines will be installed in rest of the 25 schools.

The orientation programs will be conducted as soon as the machines are installed.

As of now, the machines are installed only in two schools, we received oral feedback from the students. Since the schools are closed, girl students will use the facilities as soon as they returned to school. We planned to collect data once the students start using it.

The number of sanitary napkins dispensed from the vending machine. Usually the girls through the used napkins in the dust bins available in the toilets or in the lavatories or in hidden areas. We can observe that after installing the incinerators, the used napkins are properly disposed.

Installation of the machines and orientation programs in all the schools. Make sure the girls are using the facilities properly. Make sure the management is filling the sanitary napkins and maintaining the machines.

(20) Describe any changes in beneficiary behavior, skills or capacity as a result of the project.

Buying of sanitary napkins in the shops sometimes creates embarrassing situation to these girls. Girls from poor families cant afford to buy expensive napkins and use traditional method(waste cloth) napkins. And most of the girls who use sanitary napkins dispose the used napkins in the lavatories. Disposal of Sanitary Napkins in restrooms leads to blockage of toilets and involves huge cost in regular maintenance. In Schools /Colleges /Large institutions disposal of sanitary napkins cause untidy and unhygienic environment in the premises. Conventional way of disposing napkins is no longer acceptable as it will create environment pollution and it leads in spreading disease.

Now, as a result of this project, the girls behavior changes & they start using the low cost napkins from the vending machines & they start disposing the used napkins through incinerator which is very much hygiene.
